April 4, 2016

The Anamosa Board of Education met in regular session on April 4, 2016, at 7:00 p.m., in the Anamosa Schools Administrative Offices with President McKean presiding. Members present: Behnke, Riniker, Kilburg, Claussen, Sayre and Braden.

A public hearing was held at this time in regard to the 2016-17 Certified Budget. No one in attendance spoke to the matter so the hearing was closed at 7:01 p.m. by President McKean.

A public hearing was held regarding the 2015-16 Budget Amendment. Again no one spoke for or against the budget amendment so President McKean declared the hearing closed at 7:02 p.m.

Motion by Behnke, seconded by Riniker to adopt the agenda, as printed. Motion carried 7-0.

Motion by Behnke, seconded by Riniker to accept the recommendation of the Superintendent and that the employment of John Rahn as a 1.0 FTE Teacher, assigned to the High School Success Center At-Risk, be terminated effective at the end of the 2015-16 school year for the reasons that were set forth in the Superintendent's Notice and Recommendation to Terminate the Teaching Contract of John Rahn. Motion carried 7-0.

Motion by Behnke, seconded by Riniker to approve the hiring of Jessica Luetkemeier, Elementary Level II/III Special Education Teacher, effective with the start of the 2016-17 school year. Motion carried 7-0.

Motion by Behnke, seconded by Riniker to approve the hiring of Theresa Kent, 2<sup>nd</sup> Grade Teacher, effective with the start of the 2016-17 school year. Motion carried 7-0.

Motion by Behnke, seconded by Riniker to approve the hiring of Julie Rice, K-6 ELP Teacher, effective with the start of the 2016-17 school year. Motion carried 7-0.

Motion by Behnke, seconded by Riniker to approve the hiring of Rob Justis, Head Varsity Volleyball Coach, effective August 1, 2016. Motion carried 7-0.
