ISSUE: Approval of 2011-2012 School Calendar

BACKGROUND:

The proposed 2011-2012 School Calendar was developed by a calendar committee composed of 2 staff members from each of our three buildings. Rather than create three calendars and have people vote, we developed one calendar with input from all buildings.

This proposed calendar was sent to all staff for their review and we requested any comments or opinions be directed to a calendar committee member.

- 1. The State Fair ends on Sunday, August 21.
- 2. We are offering the "extra day for extra pay" professional development day for teachers on the Friday before we start with the required PD days. While we encourage all teachers to attend, this day is not mandatory. If a teacher is unable or chooses not to attend, there is no type of leave that can be used to allow the teacher to be paid for the day.
- 3. The first day of school is the corresponding day to this year.
- 4. Winter Break is the same number of days as this year. The actual calendar dates are also the same. The difference is that next year, we will have school on Thursday, December 22, and return on Tuesday, January 3. (This year, those dates were Wednesday and Monday.)
- 5. Spring Break is the same week as Kirkwood's Spring Break next year.
- 6. We will keep the same PD early dismissal schedule for next year as we did this year. We worked with trying to have 2 days per month at 2 hours each, but most months had either extended vacations or a full-day PD already scheduled. It just did not work.
- 7. We will have Good Friday and Easter Monday off. Easter Monday will be a designated Snow Make-Up day, however.

THE SUPERINTENDENT'S RECOMMENDATION IS:

"Approve the 2011-2012 school calendar. Because of the start date prior to August 30, we will be requesting an Early Start Waiver from the Department of Education."

Enclosed you will find copies of 28E Agreements for Computer Networking Academy and Metal Fabrication Academy. These are updated contracts because of changes in the name and description of the course. The purpose of these agreements is to assist Anamosa students with the opportunity to enroll in these courses not offered in our district or to accommodate their schedule to be able to attend Kirkwood Academy classes.

These agreements automatically renew for successive one year periods unless either party notifies the other party in writing of its termination.

Educational Services Agreement For the

METAL FABRICATION ACADEMY (formerly Advanced Manufacturing Technology) Between

Anamosa Community School District And Kirkwood Community College

WHEREAS, the Anamosa Community School District, hereinafter referred to as DISTRICT, wishes to provide for certain of its students to receive instruction in the METAL FABRICATION ACADEMY, and

WHEREAS, KIRKWOOD COMMUNITY COLLEGE, hereinafter referred to as KIRKWOOD, has the expertise to provide instruction to high school students in the area of METAL FABRICATION, and

WHEREAS, the DISTRICT is a party to that certain Educational Services Agreement for Career Edge to which Kirkwood Community College, Grant Wood Area Education Agency, The Workplace Learning Connection and certain other School Districts are also parties ("Master Agreement"). The purpose of such Master Agreement is to establish and operate joint academic programs such as that contemplated by this Agreement.

WHEREAS, pursuant to Chapter 28E of the Code of Iowa, the parties for mutual consideration and benefits agree to provide joint services on the terms and conditions hereinafter set forth.

- The purpose of the Agreement is to assist specified DISTRICT students to prepare for the world of work by receiving instruction in METAL FABRICATION and to utilize the expertise of KIRKWOOD in providing such instruction.
- 2. The DISTRICT agrees to:
 - (a) provide administrative and career counseling support to students enrolled in the program;
 - (b) provide students with KIRKWOOD program information;
 - (c) grant high school credit for successful college course completion;
 - (d) pay KIRKWOOD the agreed upon cost per pupil as outlined in the Jones Regional Education Center Partnership Master Agreement.
 - (e) require all students to comply with KIRKWOOD'S admission, registration, health and safety rules and regulations in addition to the policies and procedures published in the Kirkwood catalog.
 - (f) perform and abide by the applicable terms and conditions of the 28E Master Agreement for Career Edge.

KIRKWOOD agrees to:

- (a) provide instructional support to the program and teacher or, provide appropriate instructional staff;
- (b) comply with national, state, and local standards regarding student safety, facilities, and equipment;
- (c) serve as the fiscal agent to establish and maintain the budget;
- (d) to form and utilize an Advisory Committee to assist in the development and implementation of the program;
- (e) develop and maintain the curriculum;

It is further mutually agreed that:

- during the term hereof and upon termination of the foregoing program, any student materials or property (real and personal) provided by the DISTRICT shall remain the property of the DISTRICT and any property (real and personal) provided by KIRKWOOD shall remain the property of KIRKWOOD.
- (b) the DISTRICT agrees to provide liability insurance with respect to conduct of the educational program described above. The DISTRICT agrees to have KIRKWOOD named as an additional insured pursuant to the aforesaid liability policy;
- (c) to comply with provisions of the Carl Perkins Vocational Education Act;
- (d) to follow all state and federal statutes regarding nondiscrimination on the basis of race, color, national origin, sex, handicap, religion, or economic status.
- 4. Based upon the mutual concern for the needs of students pursuing a METAL FABRICATION career and in an effort to provide a seamless education program that builds on past learning experiences and eliminates unnecessary duplication of instruction, KIRKWOOD subscribes to the following articles:
 - (a) students who successfully complete the following course (s) will be awarded college credit at Kirkwood Community College as follows:

(and other courses from Kirkwood Metal Fabrication Program)

- (b) high school METAL FABRICATION ACADEMY students are registered as Kirkwood Community College students and therefore will have a Kirkwood Community College transcript.
- (c) there will be no charge to the student for Kirkwood Community College credit awarded through the agreement.
- 5. This AGREEMENT is exclusive with Kirkwood Community College and no assurance is given that courses awarded Kirkwood College credit will transfer to any other postsecondary institution. KIRKWOOD will work with the student toward this end, but cannot guarantee the transferability of these credits.
- 6. The duration of the AGREEMENT shall be from July 1, 2010 to June 30, 2011. This Agreement shall automatically renew for successive one (1) year periods unless on or before March 1st of any year, one party notifies the other in writing of its termination of this Agreement.
