Comments:

Thomas bid had only a 260 hp engine. Spec was 270 hp, BlueBird bid 280 hp. Both Companies use Cummins Engines.

Thomas bid a 200 amp alternator, spec was 240 amp, BlueBird offered a 245 amp. Our current transits came with 185 and 195 amp alternators and we had to retrofit with 250 amp units.

Thomas does not offer a no-spin rear axle. This is extremely helpful in winter weather and is still offered from BlueBird.
